The following conditions apply:

- All trees/plants requested for removal/eradication MUST be recognised fruit fly host plants.
- All trees/plants requested for removal/eradication on rural properties, must be in the vicinity of the residential premises or garden. Orchard trees are NOT eligible for removal through this project.
- This offer does NOT include stump removal.
- Trees/plants will be removed/eradicated by a qualified, independent contractor, nominated by the GMV Regional Fruit Fly Project.
- Timing of removal/eradication will be dependent upon demand for this offer.
