## **REPORT:**

As Councillors may be aware, staff have been developing the Council's Fit for the Future submission.

While the Council has been involved in this and has seen draft documents at various stages, the process is now to the point where the Council needs to formally review these and determine whether they meet its needs in terms of making the best submission that it can.

The submission and supporting documents reflect the Council's preferred position to stand alone and continue as the Berrigan Shire Council into the future.

The Council's adopted position reflected its earlier review of strategic capacity, Fit for the Future financial benchmarks and both the internal and independent businesses cases that considered the merger proposal and the stand alone option.

It can be seen from the Community Engagement Report that the community almost universally reflects the Council's preferred position.

If the Council is of the opinion that the submission and its supporting documents accurately reflect its position then it should formally adopt these and submit these to IPART by 30<sup>th</sup> June 2015.

Development of the Council's submission has been extremely time consuming however I believe it has been a worthwhile exercise. I particularly thank Jo Ruffin, Matt Hansen and Carla von Brockhusen for their significant contributions to the project. The co-operation of Jerilderie Shire Council in developing the merged Council business case was also appreciated.

It is quite clear from the development of the submission that all of the facts continue to support the Council's position that the stand alone option reflects the best possible outcome for the community over the long term.
